**Re:** **BOARD OF DIRECTORS – CALL FOR NOMINATIONS**

The Manitoba Nurses Union Constitution and By-Laws require that the election of Board Members shall be completed at least two weeks prior to the Annual Meeting (Article 12.03). Elections are required as follows:

**Nominations and Elections Procedure: PLEASE OBSERVE THE DEADLINES THAT HAVE BEEN SET:**

All nominations and elections shall be conducted in accordance with the MNU Handbook, under Section C – The People, 5. Elections and Vacancies – Board Members. Nominations for Board Members are to be made on the enclosed form. Note that each nomination must be made by a Manitoba Nurses Union member and supported by two additional Manitoba Nurses Union members (Article 11.02 of the MNU Constitution). **All nominations, plus resumes, are to be received in the MNU office by midnight on WEDNESDAY, JANUARY 15<sup>th</sup>, 2020. Incomplete submissions will be considered invalid.** The Nominations & Elections Committee will ensure that a list of candidates is prepared.

***In the event there are no nominations from a Region / Local, a second call for nominations will be sent to the affected Region / Local. The Region / Local will have an additional week to submit nominations for the Board representative. That nomination must be received by midnight on Monday, January 27<sup>th</sup>, 2020.***

***In the event only one nomination is received and only one person is to be elected, the person will be considered elected by acclamation. No vote will be required.***

The list of candidates and resumes will be emailed to Locals/Worksites and posted on the MNU Member Portal by **Friday, January 31<sup>st</sup>, 2020.** Resumes will be circulated EXACTLY as submitted, i.e. they will not be re-typed. Candidates may submit a photograph to be posted with their resume. The resumes should be provided in Microsoft Word and the photograph should be provided in a jpeg format.

#### **Campaigning Process:**

All nominees shall have access to all Local / Worksite members that they would represent. The Local / Worksite Presidents shall facilitate this access at the request of the nominee. For example, a "General Membership Meeting" or a "Meet and Greet" may be scheduled. **Campaigning shall not proceed until the list of confirmed nominees has been circulated by MNU Provincial Office.**

#### **Election Process:**

If an election is required, electronic voting will be used.

As outlined in Section C of the MNU Handbook, MNU will be using electronic voting to conduct the electronic voting process. Each elector will be provided with instructions on how to login to the MNU member portal where they can view the resumes of the candidates and cast their vote. Once the voter has submitted the ballot, the results are encrypted and kept anonymous. The voter is issued a receipt and is blocked from voting in this election again. **Elections, if required, will take place between the hours of 0001 on February 27<sup>th</sup>, 2020, and 1600 on February 28<sup>th</sup>, 2020.** Once voting has ended, the results will be immediately available to the Nominations & Elections Committee.

Following the completion of the electronic process, the Chairperson will notify all candidates of the results, including a vote count. Thereafter, a memo announcing elected Board members with a vote count, will be sent to all Regions / Worksites / Locals.
